PURPOSE: The Youth and Parents participating in or attending Youth Programs sponsored by Sts. Constantine and Helen Greek Orthodox Church Youth Ministries are required to conduct themselves according to the Sts. Constantine and Helen Greek Orthodox Church Youth Ministries Code of Conduct that follow this introduction. The code operates in conjunction with the guidelines and regulations of the specific activity and/or event.

CODE OF CONDUCT

As a participant of Sts. Constantine and Helen's Youth Program and the Greek Orthodox Church, I realize that I represent my Parish and my faith in all activities, both in and out of the Church. As participant in the Youth Ministry, I will pledge to:

- Attend Church and Sunday School regularly and participate in the Holy Sacraments as often as possible.
- Be responsible for my own behavior/conduct, uphold high standards for the group and accept the consequences for inappropriate behavior.
- Give my time, talents and gifts for the good of the ministry
- Practice good citizenship, leadership and self-governance
- Participate fully in programs or events
- Follow the directions of the Priest, Director, Teacher, Choreographer, Advisor, Coach or other members of the Youth Committee.
- Demonstrate positive sportsmanship and attitude at all times, on and off the court or dance stage.
- Grow in my relationship with Jesus Christ
- Treat all that I come into contact with respect and love
- Dress appropriately for all activities
- Use appropriate language at all times
- Be respectful of others

I realize that there are certain things that **will not be tolerated** in the Youth Ministry and **I will not:**

- Ø Use or be in possession of alcohol, drugs or tobacco
- Ø Engage in unsportsmanlike or unethical behavior
- Ø Use improper language or actions
- Ø Physically, verbally or emotionally abuse others
- Ø Engage in aggressive behavior
- Ø Engage in any type of sexual activity
- Ø Be **disrespectful** to others including adults, volunteers, staff, referees/judges or those in leadership positions
- Ø Bring any fireworks, guns, knives or any other type of weapon
- Ø Willfully damage property of others
- Ø Violate the stated curfew for the event

ACTIONS FOR CODE OF CONDUCT VIOLATIONS

1. The advisor / coach / choreographer /director of the youth involved will notify the youths' parent(s) or guardian of the violation.
2. The parents will be notified of the incident and actions taken by the advisor / coach / choreographer /director in charge of the event. When necessary arrangements will be made to remove the youth from the event by their parents or legal guardian.
3. The youth may be suspended and not be allowed to participate in any other events. Example: If a GOYA age youth participating in GOYA basketball, dance and religious education is suspended from dance or religious education, he or she may also be suspended from GOYA basketball. Only the Religious Education Director or Priest can suspend a youth from the religious education program.
4. If the youth and/or parents of the youth fail to correct the violation it will be referred to the Youth Director and Parish Priest who have the option for removing the youth from the program.
5. If necessary the situation may be turned over to the proper law enforcement authorities.
